The total premiums paid for the plan year ending December 31, 2018 were \$1,921,642.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2018, the premiums paid under such "experience-rated" contracts were \$504,723 and the total of all benefit claims paid under these experience-rated contracts during the plan year was -\$7,137.

This is a summary of the annual report for the ASSOCIATED UNIVERSITIES INC RETIREMENT PLAN, (Employer Identification No. 11-1630900, Plan No. 001) for the period January 1, 2018 to December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$5,656,749. These expenses included \$52,667 in administrative expenses and \$5,604,082 in benefits paid to participants and beneficiaries. A total of 1,190 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$138,185,634 as of December 31, 2018 compared to \$144,040,154 as of January 1, 2018. During the plan year the plan experienced a decrease in its net assets of \$5,854,520. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$-197,771, including employer contributions of \$3,871,835, others contributions of \$326,287, earnings from investments of \$-4,455,221 and other income of \$59,328.

The plan has a contract with TIAA-CREF which allocates funds toward individual policies.

THESE EXPENSES INCLUDED \$5,785,107 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES. A TOTAL OF 917 PERSONS WERE PARTICIPANTS IN OR BENEFICIARIES OF THE PLAN AT THE END OF THE PLAN YEAR, ALTHOUGH NOT ALL OF THESE PERSONS HAD YET EARNED THE RIGHT TO RECEIVE BENEFITS.
