Addenda I COVID-19 Requirements

Visitors/contractors must be "fully vaccinated" against the COVID-19 virus prior to their visit. Fully vaccinated visitors are those that have completed the two-dose mRNA series or single dose of Janssen vaccine, and are up to date on boosters, two weeks prior to entering the Observatory facilities. If your two-dose mRNA series vaccine (Pfizer or Moderna) was completed over 5 months ago, or if your Janssen vaccine (Johnson & Johnson) was completed over 2 months ago, you must confirm that you are up to date on the booster vaccine.

NRAO must be informed in advance of the visit via the Visitor Registration Form at https://info.nrao.edu/oas/export-import/oas/dpscompliance (or https://science.nrao.edu/about/socorro/nrao-nm-visitor-registration for New Mexico sites). It is the responsibility of the contractor to provide evidence of full vaccination to their Observatory contact upon arrival. Such evidence is satisfied by presenting the vaccination record prior to commencing work activities.

NRAO follows the guidance of the National Science Foundation and the Centers for Disease Control for COVID protocols. Note that changes in guidance from these organizations may cause adjustments to any or all of these guidelines.

- All contractors working inside NRAO building(s) are required to sanitize all areas where contact was made including commonly touched surfaces with an approved EPA disinfectant effective for COVID-19 virus.
- 2. Keep to defined/designated work areas, i.e. do not go into areas not authorized by this contract.
- 3. No eating, drinking, smoking, or any action that necessitates removal of the face covering shall occur during the work activity.
- 4. The Observatory facilities are federal buildings, and the indoor mask requirement applies to all contractor/vendor personnel, even when fully vaccinated. All contractors are required to provide and wear face coverings when entering NRAO building(s), and the face coverings must be worn until exiting the building(s). If other respiratory protection is required by the contractor during the course of work, face coverings are required upon doffing more stringent respiratory protection.
- 5. When performing work at NRAO building(s), the NRAO contact will keep a contact log, see Appendix A. This contact log must be turned into the NRAO Business Manager at the end of the work. The contact log will be kept confidential and only used for contact tracing purposes if needed.
- 6. When contractors are performing brief consults for inspection activities with NRAO employees, 6 foot distancing must be maintained.

Within 14 days of completion of the work, the contractor shall notify the NRAO Business Manager if any employee participating in the work tests positive or exhibits symptoms indicating the possibility of a COVID-19 infection.
